Fee Fixation Order

Issued To

on 23rd April, 2021 by application number 13-02-2021-FRC-F-114346, applied on 13th February, 2021 for determining the fees for following academic year under The Assam Non-Government Educational Institutions (Regulation of Fees) Rules, 2020:

Read: -

(1) Proposal of the Management of the non-government educational institution (by MARIA'S PUBLIC SCHOOL) with the documents, evidences, undertaking and affidavit dated 13th February, 2021.

Order: -

- 1. Whereas the Management of the non-governmental (MARIA'S PUBLIC SCHOOL) has submitted the proposal for the fixation of fee structure with an undertaking and affidavit of the authorized person of the institute on 13th February, 2021 under rule 8 of under The Assam Non-Government Educational Institutions (Regulation of Fees) Rules, 2020.
- 2. Whereas the proposal for fixation of fees has been examined and considered on the basis of the aforesaid factors as well as proofs and documents submitted by the management of the institute with reference to the relevant factors and provisions of the Assam Non-Government Educational Institutions (Regulation of Fees) Act, 2018, and the said Rules.
- 3. Whereas the personal hearing was also given to the management of the self-financed institute.
- 4. Now, therefore, in exercise of the powers conferred by section 11 of the said Act read with Rule 8 and 9 of the said Rules and subject to the conditions specified in this order, the Fee Regulation Committee hereby determines the total fee for the whole academic year by whatever name the fees may be called that shall be levied by the school per student of different standards as specified in columns 4,5 and 6 of the table below for the academic year 2021-2022,:

¹⁾ In addition to the above fee structure, the school authority may charge a one-time admission fee, from each new student for the entire duration of stay in the school, @₹ 9,964 for classes I to X and @ ₹ 11,500 for class XI and XII. No such fee can be collected in subsequent years from existing students.

Observations: ~

Salary paid to the staff should be at par with equivalent posts of the State Government.

Conditions: -

- 1. The total fee determined shall be levied for 2021-2022, academic year.
- 2. The Institute shall not collect fee amounting to more than one quarter of a year from any student at a time. However, if the Institute desires to collect the fee at a time for the whole year or for more than a quarter, then a rebate of 5% on the total fee will have to be given. Otherwise, it shall be considered as collection of capitation fee and such school shall be liable to prosecution in accordance with the provisions of the said Act.
- 3. The fee determined shall be displayed by the Institute on its notice board and official website in English and a local language.

²⁾ Other fees, by whatsoever name, such as admission/renewal fee, festival celebration fee, etc. can not be collected.

- 4. Any excess fee collected by the Institute shall be refunded to the students/parents within a period of thirty days from the date of this order.
- 5. In case, the fee determined by the Committee is higher than the actual fee collected by the Institute, then the difference of fee shall be payable by the students/parents within reasonable time.
